In compliance with the applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we would like to inform that our wholly owned material subsidiary **M/s RNFI Money Private Limited**, has received **approval** from Reserve bank of India (RBI) for the **upgradation** of its existing Full-Fledged Money Changer (FFMC) licence to **Authorized Dealer Category II** status.

Business impact and strategic rationale: -

- **Expanded services:** The AD Category II licence will enable RNFI Money Private Limited to offer remittance services, which was not possible with FFMC licence and broader suite of foreign exchange,
- **Market footprint:** The licence strengthens our digital presence in the foreign remittance market and supports scalable cross-border payment solutions.
- **Revenue and growth:** Broader forex and remittance capabilities are expected to contribute meaningfully to top-line growth and diversification of RNFI Services Limited's financial services portfolio.
- **Regulatory and operational readiness:** RNFI Money Private Limited will complete all procedural formalities required by RBI including surrender of the FFMC licence and will implement requisite compliance, governance, and operational controls associated with AD Category II status.
